1. Tender Receipt of Rs.2000/- each lot obtain from Accounts Department PIMS upon submission of written request on Company letterhead duly signed & stamp. After vetting from Purchase Department PIMS before 12:00 Noon till 21st August, 2026.
2. The interested eligible individuals and firms can visit the concerned sites through Storekeeper Condemnation, PIMS during working hours till 21st August, 2026.
3. The auction will be conducted through Open Auction, EPADs 2.0 (www.epads.gov.pk).
4. Manual bids submission will not be accepted.
5. The bidders are required to submit a Pay Order for each lot as Bid Security amounting equal as mentioned on **EPADs 2.0** in favor of Executive Director, PIMS.
6. Original Bid Security and a Stamp Paper of at least Rs. 100/= stating therein that the firm is currently not blacklisted by any Govt. Dept., / Hospitals/ International Agencies and NGOs must be submitted physically at Purchase Department, PIMS Sector G-8/3, Islamabad on bid opening date till 11:00am.
7. The above mentioned equipment shall not be sold below the Reserve Price (without taxes).
8. The quoted auction rates shall be **exclusive of all applicable taxes**. The successful bidder shall deposit the awarded amount **along with all applicable taxes** as per the prevailing Government tax laws, rules, and policies, within **seven (07) working days** of the issuance of the Letter of Award.
9. Failure to deposit the awarded amount along with the applicable taxes within the stipulated period shall render the award liable to cancellation and further action shall be taken as per the applicable rules.
10. If the bidder fails to collect the auctioned items within 20-days after the issuance of award letter, a penalty of Rs. 10,000 per day will be imposed up to five days. After that, the bid security will be forfeited, and the award will be canceled.
